- All billing is automatically charged to the credit card on file within one week of delivery unless prepayment was received beforehand.
- On-call, emergency, and weekend deliveries are due within 24 hours of delivery.
- Credit card information must be kept on file – All credit card information is stored securely according to industry standards.
- Finance Charges of 1.5% per month begin immediately if account becomes delinquent and is not rectified within 3 business days.
- Service will be suspended for all delinquent accounts that do not adhere to the payment and fee requirements.
- Payment of all fees and charges is required before service is resumed.
- Refusal without 24 – 48 hr cancellation of scheduled delivery by Delta Transport Services will result in a \$25.00 Delivery Refusal Fee.
- Fuel delivery tickets are placed on the door of delivery locations, unless otherwise requested by email.
- FUEL DELIVERY HOURS ARE WEEKDAYS : MONDAY, TUESDAY, THURSDAY; FRIDAY 7AM – 4PM
- Emergency deliveries after normal business hours, weekends, and holidays can be requested but are subject to driver availability and will incur an additional \$300.00 delivery charge if performed.
